ASSUMPTION OF RISK, RELEASE, AND WAIVER OF LIABILITY

I understand and acknowledge that motocross riding, racing, practice sessions, pit activities, and all related event operations are inherently dangerous activities that involve substantial risks of serious bodily injury, permanent disability, paralysis, death, and property damage.

The undersigned parent or legal guardian voluntarily permits the minor participant listed above to participate in the above-referenced event and fully assumes all risks associated with participation, including but not limited to:

- Collisions with other riders, vehicles, spectators, or fixed objects
- Track surface hazards and changing weather conditions
- Mechanical failure of motorcycles or equipment
- Negligence of other participants, officials, promoters, sponsors, or event personnel
- Risks associated with transportation, loading/unloading, and pit operations

In consideration for being permitted to participate in this event, the undersigned parent or legal guardian hereby releases, waives, discharges, and covenants not to sue the event organizers, promoters, property owners, track operators, sponsors, volunteers, officials, employees, agents, successors, and affiliates

(collectively referred to as the "Released Parties") from any and all liability, claims, demands, actions, or causes of action arising out of or related to any loss, damage, injury, disability, or death that may occur as a result of the minor participant's participation, whether caused by negligence or otherwise, to the fullest extent permitted under the laws of the State of Ohio.

MINOR RELEASE AND PARENT/GUARDIAN CONSENT

I certify that I am the parent or legal guardian of the minor participant listed above and that I have the legal authority to sign this agreement on behalf of the minor. I consent to the minor's participation in all event activities and agree to all terms and conditions stated within this waiver and release agreement.

I further agree to indemnify and hold harmless the Released Parties from any claims or liabilities arising from the minor participant's involvement in the event.

MEDICAL AUTHORIZATION

I authorize emergency medical treatment for the minor participant in the event of injury or illness during participation if I am unavailable or unable to provide consent. I understand that I am solely responsible for all medical expenses incurred as a result of participation.

EQUIPMENT AND SAFETY ACKNOWLEDGMENT

I certify that:

- The minor participant's motorcycle and safety equipment are in safe operating condition
- The minor participant will wear appropriate protective gear including a helmet, boots, eye protection, gloves, long sleeves, and riding pants
- The minor participant agrees to comply with all event rules, safety regulations, and instructions from event officials
